

Terms and Conditions for Facebook Competition

1. Introduction

By entering this competition, participants agree to be bound by the following terms and conditions.

2. Promoter

3. Eligibility

- o Participants must be 18 years or older.
- o Open to residents within 1.5 hour drive of Market Harborough.
